PROCLAMATION REGARDING

Ambassador to India

I, King Edmund Keli'i Paki-Silva Jr. make the following Declaration:

Constitutional Authority

- Considering the Royal Decree of November 22, 2002, That His Royal Majesty accepted the Royal Crown of the Kingdom of Hawai'i and that this decree was sealed by the original member's ancestors of the House of Nobles giving His Royal Majesty Absolute Power and Authority over the entire archipelago of the Hawaiian Islands and its People.
- Considering the Royal Proclamation that on November 23, 2002 the Kingdom is restored and that on June 21, 2003 a Declaration of Independence proclaiming the sovereignty of the independent Kingdom of Hawai'i was promulgated and signed into law.
- Considering the Constitution of the Kingdom of Hawai`i, which by its ratification the restoration of the Kingdom of Hawai`i is Forever Sealed Proclaiming that the Kingdom is a Constitutional Monarchial Government. Done this day of October 22, 2003

Apology Bill. (U.S. Public Law 103-150 – 107 Sart. 1510) admits the invasion, overthrow, occupation, and amexation of 1803 violated diplomatic treatise, international law, Law of Rations, and the United States Constitution. Under international law the Void Court ruled the only appropriate remedy is restitution. That fact gives absolute right and power to restore independent. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An authoromous independent covereign nation-state contemplation under Article 3 of the Montevideo Convention on Rights and Dutles of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, (c) government; and (d) capacity to enter into relations with the other states. The Kingdom of Hawair Invest Aut (EGAR REQUIREMENTS - AUT NUM MON, INNE DEMUND IN SANS-SIEVA, IR.).

Ancestral Royal Genealogy

Pursuant to Article 2, Section 1 of the Kingdom of Hawai'i Constitution of 2003: The highest position in the Monarchy is Edmund Keli`i Silva, Jr., hereafter referred to as Ali`i Nui Mō`ī (Sovereign King), and whose Sacred Royal Name is:

Nalikolauokalani Paki – Ka-`-i-`omaka-ola-hou-Kaluaokalani-ka-`i-mano`anu`unu`uka-lama-kea-i-ho`oku`ke`aupuni-o-Hawai'i

This sacred name is interpreted as The Supreme One; Source of the rebirth of Kaluaokalani; the Supreme One who conveys the reverberations of the white light that reestablishes the Kingdom of Hawai`i. Kaluaokalani is translated as The Second Heaven. It is the name of great strength used long ago in Hawai`i of the Pacific that is being reinvigorated in modern times. The sacred realm of the Highest Heaven is the home of the White Light that is the Source that provides for the restoration of the Kingdom of Hawai`i. The Kingdom of Hawai`i is the Kingdom of God. Hawai`i is the breath, the spirit of Most High God.

The King's heritage has been passed to him by his own (Iwi Kupunas) ancestors, who trace their Royal Genealogy back to 317 A.D. Each brought to him their own knowledge, experience and wisdom with an understanding of the responsibilities inherent in leading a Nation. This Nation shall include not only a uniting of just the Iwi Kanakas, Native Hawaiians by blood, but all the races and personalities of those born on the 'Aina (land), as well as those desiring to be citizens of the Kingdom and considered worthy as citizens by the Ali'i Nui Mō'ī.

Per ancient protocol in selecting a King, descendants of the original members of the House of Nobles (as established by King Kamehameha III), selected King Keli`i to reign as Ali`i Nui Mōʻi, High Chief and King of and for the Kingdom of Hawai`i. His royal genealogy traces back to a Long Line of Kings and Queens from both his mother's and father's side in a direct hereditary line of successions to King Kamehameha-Nui 'Ai Lu`au of Mau'i, as having the oldest and highest-ranking bloodline of Hawaiian Royalty ordained by Akua (God). His Royal Lineage exhibits an impeccable chain of custody and is in the original record of the Royal Courts and last changed in



the Royal Court in 1836. Queen Emma prophesied that a sacred child would come forward who would restore the Kingdom of Hawai'i. It was determined by the Royal Spiritual Council that Edmund Keli'i Paki-Silva Jr. is that child.

Therefore, the Crown is permanently confirmed to His Majesty.

Article 2 Section 4 - The Aupuni (Government) will consist of a Cabinet of various Royal Ministries to manage the departments of the Aupuni (Government). as appointed by the Ali`i Nui Mō`ī (Sovereign King). Ministers are commissioned and appointed by Ali`i Nui Mō`ī (Sovereign King). Their tenure is indefinite. They must be of good moral and civil conduct, have sufficient merits, and have rendered service to their community. Ali`i Nui Mō`ī (King) has the power to replace any and all Ministers.

An Ambassador represents the Kingdom of Hawai'i to their respective nation and carries out our mission therein. Ambassador Buddharaju is endowed with the power and authority to appoint deputies under her to serve the entire archipelago of the Kingdom of Hawai'i.

Main Duties and Functions of the Office

The Ambassador— or Chief of Mission, heads the mission's "country team" of Kingdom of Hawai`i personnel. Responsibilities of Chiefs of Mission at post also include:

- Speaking with one voice to others on Kingdom policy—and ensuring mission staff do likewise—while providing to the King via the Minister of Foreign Affairs expert guidance and frank counsel;
- · Directing and coordinating all in-country affairs;
- Cooperating with other Kingdom ministries so that foreign policy goals are advanced; security is maintained; and local responsibilities are carried out;
- · Reviewing communications to or from mission elements;
- Taking direct responsibility for the security of the mission including security from terrorism
 and protecting all Kingdom personnel on official duty and their dependents;
- Carefully using mission resources through regular reviews of programs, personnel, and funding levels:
- Reshaping the mission to serve Kingdom interests (and values), and to ensure that all branch
 agencies attached to the mission do likewise; and
- Serving Subjects with professional excellence, the highest standards of ethical conduct, and diplomatic discretion.
