

LEGAL AUTHORITY TO RESTORE THE KINGDOM OF HAWAI'I CONFIRMED

The authority to restore the Kingdom does not come from man but from Akua (î) – God, creator of this world, the universe, and all that is. Akua makes and humbles Ali'i's (High Chiefs, Kings). Kings were not appointed by man but by God to fulfill holy prophecy. On June 23, 2003, I was ordained (chosen) by His Excellency, Regent, Prime Minister of the Restoration of the Kingdom of Hawai'i, Samuel Keolamauloa Kaluna, Jr., approved by the Na Kupuna Council Hawai'i Nei, Na Kupuna Council Hawai'i Moku, to begin mending the broken hearted, the decapitated spirits and return the Kingdom back into the community of nations for perpetuity.

The illegal overthrow gives me the mandate to restore the Kingdom. My cousin Queen Lili'uokalani yielded the throne under duress, fear and concerns for her people. Further validation of the illegal, immoral acts stated by: United States Public Law 103-150, which is a Joint Resolution of the U.S. Congress, known as The Apology Resolution, adopted in 1993 that "acknowledges that the overthrow of the Kingdom of Hawai'i occurred with the illegal participation of agents and citizens of the United States, that the Native Hawaiian people never directly relinquished to the United States their claims of their inherent sovereignty as a people over their national lands and natural resources either through the Kingdom of Hawai'i or through a plebiscite or referendum".

- January 17, 1893, the overthrow of the Kingdom government by a treasonous group composed primarily of foreigners and backed by United States Marines was an act of war that violated the treaty between the Kingdom and the United States and violated international law.
- The United States government admitted to that illegal act and agreed that Hawaiians never gave up their sovereignty per The Apology Resolution.

- The illegal overthrow led to the creation of the Provisional Government, which attempted to secure a treaty of annexation with the United States. The United States Senate refused to ratify the treaty, making the Annexation null and void.
- The Provisional Government was followed by the Republic of Hawai'i. The Republic sought to have a treaty of annexation approved by the United States that would extinguish Hawaiian independence.
- The United States Senate never ratified that treaty.
- Annexation illegally took place through a joint resolution passed by the United States Congress on July 7, 1898.
- A resolution passed by a government is applicable only within that government's jurisdiction and cannot change the legal status of another government.
- The history of the failed and illegal annexation attempts only substantiates the Kingdom of Hawai'i's legal status confirmed!

Summary:

In my opinion, and that of my iwi kupuna's (Ancestors), we see the government of the United States as the wrong doers. The U.S. Government see us as a threat to their control over our stolen lands, culture, religion and traditions.

We do not seek recognition from the wrong doers who stole the Kingdom—we don't need it. Why? They cannot grant what they can't give, for they have never had authority over us. They are not sovereigns, enlightened, nor conquerors but an indescribable evil, that is void of 'Ha' breath, which is life.

Apology Bill. U.S. Public Law 103-150 - 107 Stat. 1510, admits the invasion, overthrow of 1893, occupation, and annexation of 1898, violated diplomatic treaties, international law, Laws of Nation, and the United States Constitution. Under International law, the World Court generally rules the only appropriate remedy is reparation and restitution. That fact alone gives absolute right and power to restore independence. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An autonomous independent sovereign nation-state contemplated under Article 1 of the 1933 Montevideo Convention on Rights and Duties of States requiring the state as an entity of international law possessing the four qualifications: (a) a permanent population, (b) a defined territory, (c) government; and (d) the capacity to enter into relations with the other states.

I might add, as indigenous People of the land we also enjoy the vibrant, distinctive language of our Ancestors. The Kingdom of Hawai'i meets ALL LEGAL REQUIREMENTS.

The evidence herein clearly RECONFIRMS my legal authority and jurisdiction to PROCLAIM the Kingdom of Hawai'i back in good standing among the nations of the world.
