Aloha! In this “Hallowed” Hall, we must be viciously honest in speaking truth to light that will lead to peace, healing, and reconciliation. I want to acknowledge and extend my hand of aloha to Dr. Melida Harris Barrow, her beloved late husband Mr. Felipe Barrow, and her capable Staff for bringing this event into reality; as well as this esteemed body, the Government of Panama City Panama and her people as well as The Kingdom of Hawai‘i – Nou Ke Akua Ke Aupuni O Hawai‘i, all African Nations, Tribal High Chiefs, Kings, Queens, Prince, Princesses, and everyone listening across the world.

As an Indigenous man, Hereditary King, grandfather, father, son, brother, uncle, and great uncle, how can I, in good conscience address Peace and Reconciliation without first discussing the great evil recognized for what it is — EVIL.

Therefore, be in known that I am here representing All Indigenous nations around the world whose voices have been silent. It is my sacred duty as King, to undo the Substantial Wrongs perpetrated against them, and the lawful Hawaiian Government that was illegally deposed by the United States of America in 1893. Since 1893, the United States of America has protected its GREAT EVIL under a body guard of political lies to make it sound as though the annexation, new lands resolution, and Statehood of Hawai‘i was Legal. The world did not question what the United States did because the theft was well protected by their Laws. Over a period of time those lies became truth – that the Kingdom asked to become annexed. Their truth was never our Reality. The United States had several Treaties with the Kingdom but that did not matter. In 1893, My Cousin HRM Queen Lili‘uokalani and all Kanaka Maoli – Natives to their ancestral lands – were stolen.

On January 17, 1893 HRM Queen Lili‘uokalani said --

“Now, to avoid any collision of armed forces and perhaps loss of life, I do, under this protest, and impelled by said forces, yield my authority until such time as the Government of the United States shall, upon the facts being presented to it, undo the action of its representative and reinstate me in the authority which I claim as the constitutional sovereign of the Hawaiian Islands.”

For over 50 years, many of my people went before the United Nations to address the corruption and theft of the Kingdom, however justice is not only blind, but dumb and stupid favoring the rich and powerful who oftentimes act unwisely.

FACTS IN EVIDENCE: DEPOSING THE KINGDOM

U.S. Public Law 103-150 “The Apology Resolution” passed by the U.S. Congress and signed into Law by President William J. Clinton on November 23, 1993, apologizes for the overthrow of the lawful government of the Kingdom of Hawai‘i. They admitted the theft, and in the same stroke protected their

crime with a disclaimer saying, “Nothing in this Joint resolution is intended to serve as a settlement of any claims against the United States of America.” Their term “non-binding” highlights the hypocrisy therein.

Indigenous Nations are often disregarded and face discrimination, persecution and prosecution in the legal system of the colonizers leaving them vulnerable to extreme violence and abuse for speaking ‘Truth’.

So, where did the root of all evil start? Where did it come from? Facts in evidence tells us it came directly from the Vatican. In the year 1455, Pope Nicholas V, a Romanus Pontifex, created the “Doctrine of Discovery”. Then in 1493, Pope Alexander VI, declared this vile document Holy, the word of God. NO! There was nothing Holy about this evil. This unholy document gave ‘Absolute’ power to Britain, France, Germany, Portugal, Spain, Italy, Netherlands, and the United States, lawful spiritual authority to murder, rape, and to exterminate all Indigenous people who were not Christians and to take their lands, and natural resources, all in the name of God. If that’s the case, their God is pure evil, a Murderer, Liar, Thief, Rapist, Child Molester, Bigot, Adulterer, Racist, and Coward. My God, is benevolent, Omnipotent, Omnipresent, Slow to Anger, Forgiving, and Loving – We call him AKUA, the Great Spirit.

Effected by the issuance of the Doctrine of Discovery was the entire Western Hemisphere, Africa, Australia, Asia, New Zealand, and all the Polynesian Islands, to include Hawai‘i. The Doctrine of Discovery is the root evil that created colonization and thefts of nations.

Between 1492 and 1600 – 90% of the Indigenous populations in the Americas had died. By my calculation, more than 80 million people perished because of violence and never-before-experienced pathogens like smallpox, measles, influenza, syphilis, genital shingles, genital warts, Hepatitis B, and gonorrhea, decimated the First Nations People, nearly to extinction.

“In reality, the absolute denial of the Native Land Rights was replaced less than fifty years later when Charles V sought the advice of Francisco de Vitoria as to what the Spanish could legally and morally claim in the New World. Vitoria, in a clear rebuttal to the Pope and the discovery notion, declared that Native Peoples were the true owners of their lands,” said David Wilkens, a well-known Apache scholar of today.

The Doctrine of Discovery was the inspiration in the 1800’s for the Monroe Doctrine, which declared U.S. hegemony over the Western Hemisphere, and Manifest Destiny, which justified American expansion westward by propagating the belief that the U.S. was destined to control all land from the Atlantic to the Pacific and beyond.

In an 1823 Supreme Court case, *Johnson V. McIntosh*, the Doctrine “Discovery became part of U.S. federal law and was used to disinherit Native American Indians off their lands. In a unanimous decision, Chief Justice John Marshall writes, “that the principle of discovery gave European nations an absolute right to New World lands” and Native Peoples certain rights of occupancy. What does this mean? It means Reservation Lands. These proud people were given a life sentence to live on their ancestral lands as prisoners with harsh rules and as slaves to a foreign government not their own.

Unfortunately, this story is also repeated here in Panama to the Indigenous Tribes. They too, suffer under the same yoke, but different task masters.

In closing – I am asking this esteemed body, all who are here, and all those listening, to stand up and do what is “Right”. Reverse the EVIL perpetrated against all of Africa, all Indigenous nations, to include the Kingdom of Hawai`i, and be leaders of integrity, honor, and principled as the Almighty God “ORDAINED” and blessed you to be.

Therefore, before the World and Almighty God, on this 23rd day of May, 2022, I, Edmund Keli`i Silva-Paki Jr., the Hereditary King of the Kingdom of Hawai`i – Nou Ke Akua Ke Aupuni O Hawai`i, declare that I did, on May 19th, 2022, DIRECT the Vatican’s Chief Magistrate Pope Francis Jorge Mario Bergoglio Bishop of Rome, (Vicar of Jesus Christ, Successor of the Prince of the Apostles, Supreme Pontiff of the Universal Church, Primate of Italy, Archbishop and Metropolitan of the Roman Province, Sovereign of the State of Vatican City, Servant of the Servants), to OVERTURN the Doctrine of Discovery effective immediately, and to personally apologize to all the Indigenous Nations that were negatively impacted by this Decree issued by his ancestors Pope Nicholas V and Pope Alexander VI for crimes against Humanity. I also called upon the European Royals that carried out the orders of the Vatican, knowing it was wrong, to apologize for their crimes that has gone unchecked, immediately.

My voice is strong. *Together* we will sound like thunder and the healing that is long over-due can begin.

Therefore, I Declare and proclaim this Directive on this day of May 23, 2022 to go into effect immediately.
