## Royal Announcement

January 1, 2022

**From the desk of the King: Aloha e Ka Lahui Aupuni o Hawai'i a me Kona Makaainana.**

Makemake au iā 'oukou a pau i ka makahiki hou pōmaika'i a pōmaika'i. I wish you all a blessed and prosperous New Year.

In 2002, I declared our independence and sovereignty from the United States of America. Today, our nation – Kingdom of Hawai'i – Nou Ke Akua Ke Aupuni O Hawai'i, is recognized by many nations around the world as an Independent Kingdom nation that is not a part of the United States.

I have argued, any meaning in life must be created by ourselves, and once we accept this responsibility, we can build a fresh sense of purpose and affirmation. A key component is accepting the challenges and limitations that our life will bring genuine meaning to what is important to us as a Nation. It is wisdom to know this reality.

Genuine kindness to self is trusting our inner vibrancy to stoke the flames and generosity of the heart. Therefore, we must always be mindful that hard times require us to act on our best qualities.

Apology Bill. (U.S. Public Law 103-150 – 107 Stat. 1510) admits the invasion, overthrow, occupation, and annexation of 1893 violated diplomatic treaties, international law, Laws of Nations, and the United States Constitution. Under International law the World Court ruled the only appropriate remedy is restitution. That fact gives absolute right and power to restore independence. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An autonomous independent sovereign nation-state contemplated under Article 1 of the Montevideo Convention on Rights and Duties of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, (c) government; and (d) capacity to enter into relations with the other states. The Kingdom of Hawai'i meets ALL LEGAL REQUIREMENTS

We are already a Sovereign Nation. Be the nation. Live the reality. And, honor who you are, you are Kanaka Maoli, the people of The Kingdom of Hawai'i.

### Closing Remarks

“Convenient Truth” is based on need, desire, and emotion. It is the truth that deceivers seek. It is the truth that people seek when they want to be right and know they are wrong. This “Convenient Truth” has served the U.S. Government since they Illegally Overthrew our government, the Kingdom of Hawai'i on January 17, 1893.

In the words of Kamehameha I in 1797 and in our Constitution: “We will honor our god, respect the rights of the great and humble and be free to go forth without fear of harm”.

We, are a SOVEREIGN NATION, a political entity that is represented by one centralized government, the Kingdom of Hawai'i. I speak from Kamakahonu, the First Capital of the Kingdom of Hawai'i that is grounded by divine creator - Ahu'ena Heiau, the First Temple on earth of which I am its protector, High Priest and Prophet. In the year 2000, descendants of the Original House of Nobles, along with the blessings of the Temple of Lono, the voices of the people, and spiritual communities, supported by my Royal Genealogy, Declared 'Me', Ali'i Nui Mo'i.

I have not sought nor needed permission either from the ICJ International Court of Justice, ICC International Criminal Court, PCA Permanent Court of Arbitration, the U.S. Congress, the United Nations, the U.S. Illegal State of Hawai'i, or any nation on earth to move the Kingdom forward. It is my 'Duty' to reverse what my cousin, Queen Lili'uokalani, was forced to do under threat of life, for herself, and that of her people. It is my position to install the Kingdom as a Non-Aligned Nation, and to enter into Treaties with ALL nations as Protectorate, and friends of the Kingdom of Hawai'i, in Perpetuity.

I am the Protector, High Priest, Prophet, and King, of the Kingdom of Hawai'i. It is my sacred Duty to protect the Kingdom, our lands, natural resources, surrounding oceans, tradition, culture, our language, and our spirituality, that we are one with nature, the natural world, the human family and Akua.

I am calling upon all those throughout the Kingdom, and the world that have heard the facts, to stand up for truth and justice, that we are already restored. We are the natural legitimate government of these lands, we call, The Kingdom of Hawai'i.

An announcement will be made from my office to have all of you carry our flag throughout the Archipelago, that we are FREE from the United States of America. That we are Sovereign and never again subjected to their rule. Prepare yourself -- That day is soon.
