## PROCLAMATION REGARDING *Surgeon General, Kauā Nui*

I, King Edmund Keli`i Paki-Silva II make the following Declaration:

### *Constitutional Authority*

- 👑 Considering the Royal Decree of November 22, 2002, That His Royal Majesty accepted the Royal Crown of the Kingdom of Hawai`i and that this decree was sealed by the original member's ancestors of the House of Nobles giving His Royal Majesty Absolute Power and Authority over the entire archipelago of the Hawaiian Islands and its People.
- 👑 Considering the Royal Proclamation that on November 23, 2002 the Kingdom is restored and that on June 21, 2003 a Declaration of Independence proclaiming the sovereignty of the independent Kingdom of Hawai`i was promulgated and signed into law.

Apology Bill. (U.S. Public Law 103-150 – 107 Stat. 1510) admits the invasion, overthrow, occupation, and annexation of 1893 violated diplomatic treaties, international law, Laws of Nations, and the United States Constitution. Under International law the World Court ruled the only appropriate remedy is restitution. That fact gives absolute right and power to restore independence. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An autonomous independent sovereign nation-state contemplated under Article 1 of the Montevideo Convention on Rights and Duties of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, (c) government; and (d) capacity to enter into relations with the other states. The Kingdom of Hawai`i meets ALL LEGAL REQUIREMENTS - ALI`I NUI MŌ`I, KING EDMUND K. PAKI-SILVA, JR.

 Considering the Constitution of the Kingdom of Hawai'i, which by its ratification the restoration of the Kingdom of Hawai'i is Forever Sealed Proclaiming that the Kingdom is a Constitutional Monarchial Government. Done this day of October 22, 2003

## *Ancestral Royal Genealogy*

**Pursuant to Article 2, Section 1 of the Kingdom of Hawai'i Constitution of 2003:** The highest position in the Monarchy is Edmund Keli'i Silva II, hereafter referred to as Ali'i Nui Mō'i (Sovereign King), and whose Sacred Royal Name is:

Nalikolauokalani Paki – Ka`-i`omaka-ola-hou-Kaluaokalani-ka`i-mano`anu

`unu`u-ka-lama-kea-i-ho`oku`ke`aupuni-o-Hawai'i

This sacred name is interpreted as The Supreme One; Source of the rebirth of Kaluaokalani; the Supreme One who conveys the reverberations of the white light that reestablishes the Kingdom of Hawai'i. Kaluaokalani is translated as The Second Heaven. It is the name of great strength used long ago in Hawai'i of the Pacific that is being reinvigorated in modern times. The sacred realm of the Highest Heaven is the home of the White Light that is the Source that provides for the restoration of the Kingdom of Hawai'i. The Kingdom of Hawai'i is the Kingdom of God. Hawai'i is the breath, the spirit of Most High God.

The King's heritage has been passed to him by his own (Iwi Kupunas) ancestors, who trace their Royal Genealogy back to 317 A.D. Each brought to him their own knowledge, experience and wisdom with an understanding of the responsibilities inherent in leading a Nation. This Nation shall include not only a uniting of just the Iwi Kanakas, Native

Hawaiians by blood, but all the races and personalities of those born on the `Aina (land), as well as those desiring to be citizens of the Kingdom and considered worthy as citizens by the Ali'i Nui Mō'i.



Per ancient protocol in selecting a King, descendants of the original members of the House of Nobles (as established by *King Kamehameha III*), selected King Keli'i to reign as *Ali'i Nui Mō'i*, High Chief and King of and for the Kingdom of Hawai'i. His royal genealogy traces back to a Long

Line of Kings and Queens from both his mother's and father's side in a direct hereditary line of successions to *King Kamehameha-Nui 'Ai Lu'au* of *Mau'i*, as having the oldest and highest-ranking bloodline of Hawaiian Royalty ordained by *Akua* (God). His Royal Lineage exhibits an impeccable chain of custody and is in the original record of the Royal Courts and last changed in the Royal Court in 1836. Queen Emma prophesied that a sacred child would come forward who would restore the Kingdom of Hawai'i. It was determined by the Royal Spiritual Council that Edmund Keli'i Paki-Silva II is that child.

*Therefore*, the Crown is permanently confirmed to His Majesty.

**Article 2 Section 4** - The Aupuni (Government) will consist of a Cabinet of various Royal Ministries to manage the departments of the Aupuni (Government). as appointed by the Ali'i Nui Mō'i (Sovereign King). Ministers are commissioned and appointed by Ali'i Nui Mō'i (Sovereign King). Their tenure is indefinite. They must be of good moral and civil conduct, have sufficient merits, and have rendered service to their community. Ali'i Nui Mō'i (King) has the power to replace any and all Ministers.

Who Serves at the pleasure of the King

I, Edmund K. Silva, II, am the Ali`i Nui Mō`i (Sovereign King) of The Kingdom of Hawai`i, do hereby appoint Dr. Gordon L. Grado, into the Office of Kauā Nui, Surgeon General. He shall at all times exercise this power of authority with the highest degree of honor and integrity.

The Surgeon General represents The Kingdom of Hawai`i to the World. The Surgeon General is endowed with the power and authority to appoint Deputies under him to serve the entire Archipelago of the Kingdom of Hawai`i.



## *The Main Duties and Functions of This Office*

The overall objective of The Kingdom of Hawai'i's Health Policy is to secure the Nation's physical well-being and happiness. Specific objectives include but are not limited to:

- 👑 Creating the Committee of Wholeness consisting of twelve (12) individuals to work together to blend the Ancient Ways of Healing and the best of modern medical practices which can work together in harmony for the benefit of The Kingdom of Hawai'i and its subjects.
- 👑 Appoint six (6) individuals as members of the Committee of Wholeness, for presentation and approval by the King, whose task it is to determine the best modern medical practices that will be included and work with the Ancient Ways of Healing to benefit the subjects of The Kingdom of Hawai'i.
- 👑 Appoint six (6) individuals as members of the Advisory Body of Wholeness, for presentation and approval by the King, whose task it is to determine Ancient Ways of Healing to be included and work with the modern medical practices to benefit the subjects of The Kingdom of Hawai'i.
- 👑 Form an Advisory Body of Wholeness to include members of prestige from both the Indigenous, First Nation Peoples and distinguished and honorable members of other practices of medicine world-wide. The Advisory Body of Wholeness shall act as a resource and place of advice and insight into healing practices around the world. The Advisory Body of Wholeness shall seek out and explore all methods of healing for presentation to the Committee of Wholeness quarterly or as frequently as need may suggest.
- 👑 Design and oversee the construction of the Tree of Life Royal Healing Hospital and Research Campus.
- 👑 Work with The Kingdom Administration in coordinating personnel selection, human resources services, hiring procedures and other measures needed for the implementation and maintenance of these facilities to achieve The Kingdom's plan for well-being.
- 👑 Act as an Ambassador of Wellness for The Kingdom of Hawai'i within the Nation and throughout the world, promoting the highest level of service and capability to the world.
- 👑 Actively promote world health and seek to communicate and work in concert with other Nations to bring out World Peace and Global Wellness.
- 👑 Provide for the wellness of the King and the Royal Family as the highest priority.
- 👑 Promote Hawaiian health techniques.





## *Duties and Functions Defined*

### *Assignment*

The Kingdom of Hawai'i is at a pivotal point in the history of the country. The past is soon to be behind us and a future of our own making is at hand.

The role of the Surgeon General bears a great responsibility to bring healing back to the Nation and to protect subjects from the great evil that is permeating the world, doing harm and destroying health.

In addition, the world is in great disarray; it is critical that The Kingdom lead the way in ridding the world of the corruption that is choking freedom everywhere and in every way. This makes a harmony between modern medical practices and Ancient Ways of Healing vital in offering The Kingdom and its ancient wisdom as a guiding light in overcoming this evil destruction of life.

This blending of modern healing methods and ancient healing ways are an important legacy to the world from The Kingdom of Hawai'i. Having the best facilities and practices will demonstrate these capabilities. These are critical areas of focus for Surgeon General.

- 👑 Supporting the best practices and programs through Hawaiian Kahunas and healing masters, through First Nations around the world, and through international individuals with deep experience and understanding of the actions needed for successful implementation of this unique blending of Indigenous and modern.
- 👑 Clear, concise and consistent communication throughout all processes to ensure alignment with the King and his desires for and responsibilities to his People
- 👑 Firm, solid commitment and loyalty to the King which is demonstrated in every day actions
