Aloha Your Majesty,

The Golden Compass of Justice

How the *Law of Aloha* Transforms the Global Legal Landscape at the IICJ and IICC

In a world increasingly seeking moral clarity and holistic accountability, the recent proclamation by His Royal Majesty King Dr. Edmund Paki-Silva II of the Kingdom of Hawai'i—declaring the *Law of Aloha* as the supreme foundation of justice—is not merely a national renewal; it is a profound legal genesis with universal implications. This sacred principle, embodying compassion, respect, dignity, and harmony, is now the guiding star for the International Indigenous Criminal Court (IICC) and the Royal International Indigenous Court of Justice (IICJ), transforming them into a vital global beacon for Indigenous justice.

An Elevation of Legal Consciousness

The *Law of Aloha* fundamentally elevates the pursuit of justice above the limitations of conventional legal systems. Where adversarial traditions often prioritize precedent or procedural statutes, the *Law of Aloha* asserts a higher moral calling: that “the welfare and health of the people shall be the supreme law” (*Kanawai Kiekie o ka 'Āina*). This Hawaiian principle aligns governance directly with spiritual integrity, ancestral wisdom, and the Natural Law, which holds that laws originate from the Creator and the Land. This framework mandates that justice must inherently be compassionate and focused on righteousness, securing sovereignty not through force, but through moral authority.

The IICJ and IICC: Aloha's Global Launchpad

The establishment of the IICJ and IICC, already recognized for their unique specialization in human rights violations and long-neglected atrocities, is the perfect launchpad for this elevated jurisprudence. Seated within the sovereign Kingdom of Hawai'i, these courts are explicitly designed to overcome gaps in the international legal world that often fail victims. By adopting the Law of Aloha, the courts are formally empowered to dispense justice rooted in *Kaulike* (equality and equity) and guided by the uncorrupted wisdom of primal and celestial law.

The IICJ does not merely seek adjudication; it seeks restoration and remediation. This restorative mission is intrinsically tied to the *Law of Aloha's* emphasis on harmony—a framework that offers a model of Indigenous justice to the world, rooted in reconciliation with God, nature, and humanity. The IICJ is positioned as the “combined Indigenous Voice declaring evil and fighting against it to restore justice,” its authority derived from Akua (God Almighty) alone, ensuring its moral compass is unwavering.

For judges, advocates, and officers of the court, the *Law of Aloha* now serves as an explicit code of conduct, compelling every decision to be steeped in fairness, compassion, and dignity. This blend of



ancient spiritual principle and global institutional reach ensures that the IICJ and IICC offer a profound precedent for Indigenous nations worldwide, demonstrating how spiritual values can form the foundation of the highest form of justice. As the courts extend their reach to Indigenous communities and victims of injustice across approximately 213 nations, the Law of Aloha transforms the global pursuit of justice into a universal invitation to harmony.

The proclamation of the *Law of Aloha*, coincides with the inauguration of the first Global IICJ and IICC during His Majesty's visit to New Zealand in November 2025, and in the presence of the Māori Indigenous communities, we are proud to launch the official Attorneys' gowns (see appendix 1) for practice within the IICJ and IICC courts. This marks the unveiling of the first designs for both Senior Attorneys and Judges, as well as for Junior Attorneys of the IICJ and IICC.
