PROCLAMATION

From Sorrow to Strength: Answering the Sacred Duty to Reclaim, Heal, and Unite Hawai'i

Aloha mai ke Aupuni o Hawai'i, a me nā lāhui a pau.

I humbly acknowledge that I do not fully grasp our Heavenly Father's wisdom. Yet, I know this: many are called, and few are chosen (Matthew 22:14). The invitation to serve is open to all, but only a few respond with courage and humility. My purpose is not to seek political power, but to honor my sacred duty as an heir of High Chiefs, Kings, and Queens—to serve our people with integrity, strength, and moral direction, guided by the wisdom of Almighty God. Some may doubt my calling, but for those who believe and support these righteous efforts, I have accepted this responsibility and dedicated my life to His will. In time, I hope those who watch from the sidelines will witness positive change, embrace a noble spirit, and choose to join the Kingdom of Hawai'i, welcoming me as their *Ka Mo'i*.

The Heartbeat of Hawai‘i

The Hawaiian Islands pulse with resilience, sorrow, and unwavering hope. Since 1893, the *Kanaka Maoli* have endured dispossession—not by fate, but through deception, dominance, greed, and power. The overthrow of the Hawaiian Kingdom was not a distant event; it was a grave violation of injustice and human rights, and its wounds remain open today.

Justice, long neglected, now demands acknowledgment. The unlawful overthrow of Queen Lili‘uokalani resulted in the transfer of the First Kingdom of Hawai‘i to U.S. control. During the 1895 *Kaua Kuloko* (Civil War), over 400 Hawaiian patriots were imprisoned or detained, including Queen Lili‘uokalani and Prince Jonah Kuhio. Some received harsh sentences, while others faced threats of execution. Since then, Hawai‘i’s incarceration rate has remained among the highest in the U.S., driven by political dominance that suppresses the will of Native Hawaiians—*Kanaka Maoli* or the First Nations People of the Hawaiian Islands.

The struggle for sovereignty has endured for generations—through arrests, protests, and demonstrations for land rights and self-determination. These acts of civil disobedience were not crimes, but courageous stands for justice. Many voices were silenced, dignity stolen—not for wrongdoing, but for daring to hope and fight for what was rightfully theirs.

Today, their innocence is recognized, their honor reaffirmed, and their rightful place in humanity secured. As the reigning King, Commander-in-Chief, Guardian of sacred sites, and *Po‘o Pa‘a* of our highest court—the Supreme Indigenous International World Court—I hereby decree and declare that HRM Lili‘uokalani, born *Lydia Lili‘u loloku Walania Wewehi Kamaka‘eha*, HRH Prince *Jonah Kūhiō Kalaniana‘ole Pi‘ikoi*, and all individuals convicted are exonerated. Their names shall be spoken with honor and dignity. All rights, lands, and titles that were previously revoked due to any criminal or civil judgment are hereby restored by my ORDER, dated November 29, 2025. HRM Ka Mo‘i Edmund Keli‘i Silva – Paki II.

A Living Reality and Call to Conscience

This struggle is not merely history—it is a living reality, a call to conscience for all who believe in justice, dignity, and the sacred right of self-determination. Supporting Hawai‘i means listening deeply, seeing beyond imposed narratives, and standing in solidarity with those whose heartbeat still echoes for freedom.



Your voices are heard. Across these sacred lands, your pleas for help, peace, and justice have reached me. I stand unwavering, committed to protecting you and restoring the Kingdom that is rightfully ours. Your concerns—well-being, safety, health, education, customs, traditions, and our shared future—are not distant whispers; they are the heartbeat of our nation.

I acknowledge the pain caused by indifference from officials at every level of the United States government—those who govern without understanding, as if the lives of our people hold lesser worth. This injustice burdens us all. Yet the spirit of *'Aloha'*, rooted in heart and mind, remains unextinguished. It flows like the wind, resonates in our voices, and moves with the tides of our shared journey.

Rising Together

The dark history of our Kingdom's theft is being rectified. Now is the time for all of us to stand strong against the wave of wrongs—not with weapons, but with the most powerful tools: dignity, unity, grace, honor, justice, and moral clarity. Hawai'i—including the Kingdom of Hawai'i—has risen from despair. The challenges ahead—poverty, homelessness, cultural loss, and systemic injustice—are not impossible to overcome. They require unity, compassion, and determination. To heal, we must revive the spirit of *'Aloha'*: choosing unity over division, compassion over criticism, and justice over indifference. This is more than just survival; it's about reclaiming dignity, hope, and the basic right to recognition and respect. Guided by the wisdom of our ancestors and the strength of our people, let the world know: Hawai'i's heartbeat continues.

Royal Proclamation

By the authority vested in me as the reigning King, Commander-in-Chief, Guardian of sacred sites, and *Po'o Pa'a* of our highest court—the Supreme Indigenous International World Court.

Affirm:

Whereas the Hawaiian Islands have endured generations of dispossession, injustice, and the unlawful overthrow of the Kingdom of Hawai'i;



Whereas Queen Lili'uokalani, Prince Jonah Kūhiō, and hundreds of Hawaiian patriots were wrongfully convicted and punished for acts of courage and justice;

Whereas the dignity and honor of *Kanaka Maoli* have been suppressed, and their rightful place within humanity denied;

I hereby decree:

- All convictions against Queen Lili'uokalani, Prince Jonah Kūhiō, and every Hawaiian patriot wrongfully judged are nullified.
- Their honor is restored. Their names shall be spoken with reverence.
- All rights, lands, and titles unjustly revoked are reinstated by MY ORDER, dated November 29, 2025.
- This act is not symbolic—it is the fulfillment of justice, the clearing of falsehoods, and the restoration of truth. Hawai'i reclaims its dignity before the world.

Let this proclamation stand as a testament to our strength, compassion, and unwavering duty to correct the wrongs of history. Guided by ancestral wisdom and fortified by faith, Hawai'i rises—united, dignified, and resolute.

Nou Ke Akua Ke Aupuni O Hawai'i. Hawai'i's heartbeat endures.
